TUITION & SCHOLARSHIPS

The tuition fee is *AMD 500,000* per semester. A limited number of academic scholarships is available to all applicants.

LOGISTICS

The program is offered to graduate law students with a start date in September 2023. The program lasts 1.5 years and will be completed in three semesters. The number of places is limited to 15.

APPLICATION DEADLINES

All students, including international students and nationals whose undergraduate degree was earned at a university other than YSU, are eligible to apply. Applications are due on June 30, 2023.

ADMISSIONS

The admissions interview will not require prior knowledge of, or expertise in, the subjects of international court litigation and international arbitration, but will instead test critical thinking and logical reasoning. A sample exam question will be available online, and the interview will take short-answer form.
